Guidelines for 2021 CITS online Admission/Counselling at NSTIs and IToTs

Activities related to CITS-2021 Online Counselling for Admission Process

1. NIMI will upload the result on the NIMI portal with first merit list as well as forward to

all the institutes.

2. The merit list to be prepared based on marks obtained and considering the reservation

norms of the Central Government. The IToTs will follow the reservation norms of

their respective states.

3. There will be First, Second and third phases of counselling for admission.

i. NIMI should display the First Merit List institute-wise on the portal. The

Institutes will admit the trainees during first counselling and will inform the

admissions made and seat remaining vacant trade-wise to NIMI on the last

date of first counselling session.

ii. Transfer Process online for all provisionally admitted candidates who have

not got their first choice will be opened and candidates will be allowed to

select Institute of choice and candidate will be transferred as per merit at

the end of the day.

iii. NIMI should display the subsequent merit list institute wise on the portal

and the above procedure will be repeated by the Institutes for second and

Third Merit List.

iv. Spot admission will be given based on AICET-Merit List subject to

availability of seats. DGT will nominate officers from RDSDE for supervision

during Spot admission in IToT.

4. NIMI to share the admitted trainee data with M/s. Wipro for uploading on NCVT MIS

Portal through appropriate template or web service.

5. Any other activity as required during the admission process.
